## Help Your Patients Become Familiar with Biologic Drugs

## Patients need your help in understanding how biologics are different from other medications.

Biologic Drugs- effective but sensitive!

Explain to the patient that biologic drugs require additional care during storage, handling, and administration to guarantee their efficacy and avoid microbial contamination.

#### Empower patients for safer therapies

Advise your patients to:

- Keep a list of their medications with them at all times.
- Share a copy of the medication list with a family member/friend to provide support in the case of an emergency.
- Check their medications when received to be sure that they are correct and, if unsure, consult the pharmacist or healthcare professional before taking the drug.
- Keep a calendar to help schedule their medications.



### Advise Your Patients about how to Prepare and Administer Biologic Drugs

#### Dosage, duration of treatment and adherence

Explain the treatment and the importance of adhering to the recommended dosage schedule provided by you or a doctor. Recommend the patient to:

- Adhere to the recommended schedule, unless there are serious side effects or unforeseen circumstances such as sickness.
- Take any missing dose as soon as possible unless it is almost time for the next dose, for example, the next day. Tell them not to double the dose.
- Report to your doctor any missed doses, side effects, or if the medication schedule is too difficult to follow.

#### Route of administration

Explain how the drug is provided (prefilled syringe, pen, multidose vials, cartridge) and which is the route of administration. Recommend the patient to:

- Read the instructions to know which parts of the body are suitable for injections.
- Advise the patient to change the local site of injection with each administration.
- Advise the patient to seek professional help if not confident in the administration process.



#### Preparation of drugs

Recommend to the patient to:

- Identify whether the drug is a ready-to-use syringe/pen or if it needs to be prepared before injection.
- Follow the administration guidelines that come with the medication. Seek help from a family member/friend if they are not confident with drug preparation.
- Take out drugs stored in the refrigerator before use so that they can reach room temperature before administration.
- Not shake biological drugs.
- Identify which medical devices can be used for injection, where they can be purchased, and not to use other devices in place of those recommended.

#### Training is important!

Train the patient on how to prepare and inject the drug.

- Open the medication box and show the materials provided.
- Use a test-syringe/pen to demonstrate administration or, if possible, be present at the patient's first self-administration.
- Introduce any tools to assist in administration, such as a dosing wheel or a syringe with transparent holes to confirm a successful injection.

#### Any doubt?

## Advise your Patient about Storage and Handling of the Drug

#### For drugs that need to be stored in the fridge

Advise your patient to:

- Store the medication in the refrigerator, but keep it away from areas where it may freeze and do not store it in the refrigerator door.
- Throw out medications that have been frozen or kept warm (above 8 °C) for too long.
- Check the instructions to see how long the medication can stay out of the refrigerator.
- Use ice packs and a thermal bag while travelling, including when picking up the medication from the pharmacy or hospital. Do not put medication in the checked-in luggage while travelling. Be extra careful about warming medication while travelling in a car.

#### Safe storage and disposal

Advise your patient to:

- Keep medications out of the reach of children and pets.
- Keep the medicine in the original packaging to protect it from light, even when stored in the refrigerator.
- Throw away used syringes or pens in a suitable needle-resistant container.
- Do not keep out-of-date medicine. Return unused medication to the pharmacist or hospital.
- Consult a pharmacist or FDA's homepage if they have questions about storage and disposal.



### Advise your Patient to Keep in Contact with their Healthcare Provider

## The patient should have a dedicated healthcare professional to contact in case of issues.

Advise your patient to:

- Keep healthcare providers informed about the patient's medication and dietary supplements (including vitamins and herbs) to prevent unwanted drug interactions.
- Get advice from health care providers about travelling with biologics.
- Do not take other medicines unless they have been discussed with a doctor.
- If planning a baby, become pregnant or intend to breastfeed, refer the patient to their doctor as soon as possible
